課程概述 教學目標及範圍	隨著 21 世紀美中關係處於更多競爭關係以來，歐洲與中國不僅在戰略互動的範疇從傳統的軍事安全擴展至政治安全及經濟安全，更打破了傳統以來雙方安全戰略上並不存在衝突的觀點。誠然歐、中同為國際關係上重要的行為體，雙方在許多重要議題上存在合作與競爭。近年歐盟開始對中國的角色進行類別判定，包含「合作夥伴」、「協商夥伴」、「經濟競爭者」，以及「系統性對手」，雙方關係隨著國際與歐洲局勢變化出現較明顯的轉變。本課程在歐中歷史脈絡下，擇定雙方在政治、經濟、外交、社會文化、價值規範、制度治理等層面，就軟實力與銳實力、多極化與多邊主義、經貿發展、民主與威權、主權與人權、戰略夥伴關係、區域整合、全球與區域治理等議題進行比較探討，並從全球視角加入美、俄、日等大國以及台灣作為探討變項，期望對歐中關係有更全面認識與省思。
